Clerk to email Darren Thomas regarding the bus shelter opposite the motel and ask for the perspex to be put on the other side to shelter people waiting for the bus from the prevailing wind.

Both venues for the 12th April were already booked. Clerk to find out what time the previous commitment at Nolton Reading Rooms finished and provided it was by 8.00pm we would hold the meeting on Tuesday 12th April at Nolton, and if not then on Wednesday 13th April at Nolton instead.

M Harries mentioned volunteers in Johnston and Neyland had been patrolling to keep down speed. Clerk has contacted PCSO Jude Parr to find out more.

Bins at Ocean Drive – A Ricketts said the area was disgraceful and people was just dumping rubbish there not bothering to put them in the bins provided. M Harries said that PCC should be there 3x week litter picking but this doesn't seem to be the case. M Harries to look into CCTV there.
